### Lies Anh and Children Told

We were being molested since 2004 <- Not! Rich lived in Canada until June 2006  
Mom kept us away from molester since April 2009 <- Not! Never kept them away  
Pictures in Court showed they were at our house in June 2009.  
Sandy knew Cindy was molested (She and Cindy briefly talked about it)  
Sandy knew Cindy was molested (She seen it)

Sandy disclosed the abuse and began having hallucinations and was admitted to mental hospital <-Not! Anh the mother overdosed her on over the counter sleeping medications that caused her to hallucinate  
Sandy disclosed abuse while she was in hospital <-Not! If She did the hospital being mandatory reporters would have had to report it... Months later at Cares she says she forgot about being molested while she was in the hospital

We were both molested in July, 4 months after mom had kept them away from molester  
Cindy says she seen Rich touch Sandy's vagina at Cares NW - under/over clothes  
At Cares Sandy says Rich only touched breasts 3 times - never touched vagina  
Sandy, feeling the need from outside influences to collaborate because her sister did see it suddenly remembers Rich rubbing her vagina 2 weeks after Cares NW disclosures  
Grand Jury Cindy never seen Rich touch Sandy's vagina

They didn't want to go the splash water park. Everyone in the family would have testified that it was the main reason for the allegations  
At Cares Sandy was distinctly touched 3 times on the breasts period.  
At Grand Jury Sandy was touched so many times she doesn't even know  
Cindy was touched too many times to count

Lets calculate Cindy's lie of saying she seen her uncle touch her sister's vagina.  
At Cares she says she seen it. This convinces Cares that possibly Sandy isn't prepared to make a full disclosure at this date. ; ) Sandy remembers 2 weeks after her Cares visit calls Det. Christensen down to school for an additional disclosures then months later at Grand Jury, Cindy never seen her uncle touch her sister's vagina. Cindy just uncollaborates their whole story.  
At Cares NW neither Cindy or Sandy were worried about other kids being molested  
At Grand Jury they are both now concerned for the younger cousin's welfare

### Who is lying? You do the math...

In fact they are arguably some of the lyingest people on earth but why would they lie about something like that huh? Kevin Barton and Judge Upton had an agenda. You combine that with the fact that \$36,000.00 gets you a couple of lawyers that didn't even bother to read the police discovery because why would kids lie about something like that?, and you have the perfect anatomy for conviction. You should be disgusted with yourself Mr. Barton? Of course not, strike up another win for the win column. A win because you can. Lisa Ludwig and Graham Fisher are just disgusting. Half of the lies above were never mentioned to the jury.  
The damage and devastation that this has caused our family is irreparable and too immense for words.

My wife and I were not going to go to splash water park if Anh and her girls went due to the vicious nature of a confrontation that we had with them in the week prior to the splash water park weekend. Anh called our autistic son an animal, had apparently always called him an animal to my wife but it was the first time my wife made me aware of it. We never could have imagined what it would cost us for not taking them along that weekend. Anh is a psychopath with a long history of psychotic tendencies that coerced her kids into the allegations, Kevin Barton made certain that none of it could be brought up at trial. My lawyer Lisa Ludwig never made an offer of proof to show how psycho she was but it was my defense. Police discovery available upon request.
