At the request of Washington County Community Corrections, I conducted a Monitoring Polygraph Examination of Richard 'odav's examination was conducted at 5933 NE WinSivers Dr. Portland, OR. At 0855hrs, upon entering my office Mr monotified me of his intent to audio record the polygraph process. I advised Mr. hat he could not record the polygraph process. Mr. then explained to me the Oregon law regarding one party consent. I again told him he could not record the process of the polygraph exam. Mr. advised that, per Oregon law, he did not need my permission to record the process. I advised Mr. that he could chose to take the exam, or not take the exam, but if he chose to take the exam he would not be recording the process. advised that he was about ready to leave my office, but had another question he wanted answered first. He stated that when I provided his last polygraph exam (on 9/13/18) I had not notified him of the results. I reminded Mr. hat I had notified him of the results prior to him leaving my office on the date of the exam. Mr. stated that he had paid me for a service, yet my report was not sent to him. I reminded Mr that he had not paid for the exam. I then explained to him that regardless who paid the fee, I am contracted with Washington County to provide them with polygraph services to those they supervise. As a result my reports are provided to Washington County. Mr. turned off his recording device and sat down to take the exam. He told me that if the polygraph exam indicated he was being deceptive, that he would be taking me to court over the issue. After explaining that I wasn't worried about going to court, I presented him with the polygraph consent document and asked that he read through it. Mr stated he has already seen the document and didn't need to read it again. I explained that he needs to read and understand the consent document before we can continue. Mr stated he did not wish to take the exam and stood to leave, stating that I was refusing to provide the exam to him. I told Mr. offering him the exam, but his reading the document and consenting to take the exam was part of the then sat back down and stated he would take the exam. presented an article he described as from the American Psychological Association. Mr. proceeded to read a portion of the document, seeming to make an argument that the accuracy of polygraph is controversial. After several minutes of reading Mr returned the article to his backpack. Eventually Mr appeared to read the polygraph consent document. He then signed that he understood the document and consented to take the exam. then demanded to get a copy of today's report and threatened to sue me if he did not get a copy. In an apparent effort to prove his threats valid he attempted to present paperwork naming another person he was in the process of suing because he didn't get what he wanted from them. I

advised him that I had no interest in reading the documents, and I certainly wasn't worried about going to court. I advised that I simply wanted to provide him with a polygraph exam, if he chose to

take it.

I explained the polygraph procedure and components to Mr. even though it seemed he wasn listening. Mr. again advised that he wanted to record the polygraph process. I again advised him he would not be recording.
I reminded Mr that the window of time tested for his last exam was the prior 12 months. Because I was not able to provide an opinion as to his truthfulness regarding that window of time, advised we would be using the same starting point for today's exam. Mr advised we would only be testing for the time period covering the last six months. I told him that he could choose to take the exam, or choose not to take the exam. However, if he chose to take the exam the window i time tested will cover the past 13 months.
Manual seemed to anger even more and stated, "I don't give a shit what you're saying." and demanded that the window of time cover only the past six months. Mr. stood and gathered his belongings. As he approached the office door to leave he advised that he would be billing me for him. As he opened the door to leave he told me, "You want to do it or not? Six Months." I advised that if he chose to take the exam, the polygraph today would cover the 13 month window we spoke of. Mr. came back into my office placed his belongings back on the side table and sat back down in the chair.
Million told me he would agree to the polygraph exam, but would not be answering any of the questions prior to the actual chart recordings. He then questioned why I had to ask the chart recording questions three or more times. He told me that I only needed to ask those questions once.
At that point Mr. stanger had risen to the point I became concerned it was not conducive to a fair and accurate polygraph exam. I told him we would not be able to complete his polygraph exam today and he was free to leave. Mr. again gathered his belongings and made the statement there was nothing he could do if I was refusing to provide him with the exam. At 0915hrs Mr left my office.
At 0917hrs Mr. returned and quietly knocked on my office door. He stated he had calmed down and wanted to take the polygraph exam. Mr. demeanor seemed to have calmed considerably, so I agreed to re-evaluate him for the exam. Mr entered my office, placed his belongings on the side table and sat back in the chair. For the purpose of this exam the definition of "contact" was described as including any physical touching, direct communication of any type, and/or indirect communication of any type including through a third party. Mr. stated he understood the wording and meaning, and agreed to each question in their form.

The polygraph components were attached to Mr. and utilizing the Air Force Modified General Questions (DL) Test format I recorded three polygraph charts, asking the relevant exam questions listed on page one, in various order.

At the conclusion of the examination I reviewed each chart and found there was No Significant Responses Indicated. As a result it is my opinion Mr was truthful as he answered "No" to the relevant exam questions listed on page one.
